



#### 2. POSSESSION OF TRUST PROPERTY:




#### 3. NAME:

3.(a) Trust Head Quarter is situated at SA.6/186S-3, Shri Nagar Clonly, Paharia, Varanasi.











4. OBJECTS :

That the objects for which the Trust is founded are :-

- 4.1 To form a nucleus of Universal Brotherhood of Humanity.

- 4.4 To conduct, sponsor and organise lectures, meetings, conferences, seminars, symposiums, training camps, courses, exhibitions, fairs, competitions and/or such other programmes and activities for diffusion of knowledge.

- 4.6 To provide Scholarships, books, financial assistance etc to poor, needy and meritorious students.



  - (d) The Trust will neither embark on any business nor any activity unrelated to its objects; and
  - (e) If any of the aforesaid object(s) is found to be inconsistent with the object permissible for a charitable institution within the meaning of section 2(15), 10, 11, 12, 12A, 12AA, 13 and / or 80G of the Income Tax Act, 1961 or any other law applicable for the time being in force, the same shall be deemed to have been modified in consonance with such law.

## 5.4 <u>Utilisation of Income / Corpus</u>:




## 7. TRUSTEES :

### 8.1 Holding of Properties:


To hold and be possessed of the Trust Fund and its properties;

#### 8.2 Donations:



## 8.5 <u>Investments</u>:




## 8.9 Granting Donations:

#### 8.12 Appointment of New Trustees:


To appoint able, devoted and deserving persons dedicated to the objects of the Trust as Trustees;

To appoint, employ and remove any Agent or Attorney for the furtherance of the objects of the Trust;






8.21 Amendment:


# 11. IRREVOCABLE PUBLIC CHARITABLE TRUST :






